Play, Process and Heal: Integrating EMDR and Sandtray into Play Therapy

This workshop introduces clinicians to the integration of EMDR, sandtray, and play therapy for working with children. Participants will learn how sandtray play provides a safe, sensory, and symbolic medium that enhances EMDR phases, deepens trauma processing, and supports regulation. Through demonstration and practice, attendees will explore practical strategies for weaving EMDR into play-based sandtray interventions to engage young clients and promote healing.

Learning Objectives:

1. Describe the clinical rationale for integrating EMDR, sandtray, and play therapy in the treatment of childhood trauma.
2. Identify developmentally appropriate uses of sandtray within specific EMDR phases to support safety, regulation, and trauma processing.
3. Explain how sensory and symbolic play in sandtray enhances bilateral stimulation and adaptive information processing.
4. Learn at least six play-based interventions for incorporating EMDR principles into sandtray or play therapy interventions.
5. Apply developmentally appropriate modifications of EMDR protocols within play therapy to increase child engagement and emotional regulation.

6. Evaluate clinical considerations necessary to maintain safety and therapeutic effectiveness when integrating EMDR into play-based trauma treatment.
